Introduction

- (1) The purpose of publication is to provide a transparent indication of primary wholesale charges to existing and prospective retailers to support effective markets.
- (2) The Schedules of Indicative Primary Wholesale Charges for 2026/27 are set out in the following pages of this document. The presentation of our charges tables are aligned with the recommendations of the RWG industry group on tariff simplification.
- (3) Wholesale charges form the basis of charges to retailers for wholesale services.
- (4) Our projections assume that the CPIH inflation rate will be 3.57%. We have projected indicative charges using our current best forecast of billed consumption for 2026/27 and other charging parameters, but may revise this for final charges setting work at the end of the year, in the light of new evidence that may become available.
- (5) Our water supply area is defined in our instrument of appointment and comprises three discrete regions in the south east of England shown on the map below. Charges for the supply of water vary according to region and are shown in our schedule of charges.





Assurance Statement

The Board of Affinity Water Limited, having made due enquiry of management and having considered reports from external assurance providers confirms, to the best of its knowledge, that:

- (a) the company complies with its legal obligations relating to the indicative Wholesale Charges 2026/27 it has published;
- (b) the Board has assessed the effects of the indicative new charges on water supply licensees (as a whole or in groups) who are retailing wholesale services and (assuming such indicative charges are passed through by water supply licensees to their customers) on customers occupying Eligible Premises (as a whole or in groups) and approves the impact assessments and handling strategies developed in instances where bill increases for licensees (as a whole or in groups) who are retailing wholesale services to eligible customers and on customers occupying Eligible Premises (as a whole or in groups) exceed 5%;
- (c) the company has appropriate systems and processes in place (including up-to-date models and data) to make sure that the information published about its indicative Wholesale Charges 2026/27 is accurate; and
- (d) the company has consulted with relevant stakeholders in a timely and effective manner on its indicative Wholesale Charges 2026/27.

Tariff Simplification Plans

From April 2026 we will continue with our journey to not only combine the tariffs within our regions, but also to combine our East and Southeast regions to form a single East region. This journey will allow us to significantly reduce the number of tariffs and charging elements in our supply area while also remaining compliant with Market guidance. We will look to make the following changes.

- Large user SPID charges
 - All large user SPID charges will be removed. This relates to the current tariff codes WTMPWAWCM002, WTMPWAWEM002, WTMPWAWEM003 & WTMPWAWEM004.
- Assessed Tariffs
 - WTAWAWSEY001 in our Southeast region will be retired and the associated SPIDs moved to tariff WTAWAWEY001 in our East region.
- Unmeasured Tariffs
 - WTUWAWCY003 in our Central region will be retired and the associated SPIDs moved to tariff WTUWAWCY010.
- Special Agreement Tariffs
 - WTMPWAWCM005 in our Central region will be retired and the associated SPIDs moved to tariff WTMPWAWCH003.
- Metered Tariffs (Central region)
 - WTMPWAWCM001 will be retired and the associated SPIDs moved to tariff WTMPWAWCS001.
 - WTMPWAWCM002A will be retired and the associated SPIDs moved to tariff WTMPWAWCM002.
- Metered Tariffs (East region)
 - WTMPWAWEM001 will be retired and the associated SPIDs moved to tariff WTMPWAWES001.
 - WTMPWAWEM004 & WTMPWAWEM004A will be retired and the associated SPIDs moved to tariff WTMPWAWES001.
 - WTMPWAWEM002A will be retired and the associated SPIDs moved to tariff WTMPWAWEM002.
- Metered Tariffs (Southeast region)
 - WTMPWAWSEH001 in our Southeast region will be retired and the associated SPIDs moved to tariff WTMPWAWEH001 in our East region.
 - WTMPWAWSES001 in our Southeast region will be retired and the associated SPIDs moved to tariff WTMPWAWES001 in our East region.
 - o WTMPWAWSEM001 in our **Southeast** region will be retired and the associated SPIDs moved to tariff WTMPWAWES001 in our **East** region.

All SPIDs are subject to tariff changes based on their annual consumption, as part of the RWG Retail Price Control Groups Guidance.
