## **1** Introduction

In accordance with the Wholesale-Retail Code: Contract Schedule 1, Part 2: Business Terms (Version 2.0), we have set out the following timetable showing the dates on which we intend to issue invoices to retailers for Primary and Non-primary charges. Terms using capitals have the meaning given in the Wholesale Retail Code.

Invoices will be issued electronically to the email addresses provided by Retailers by 5pm on the date stated. Retailers must ensure that they settle invoices within the timescales set out in the Wholesale-Retail Code and by the Market Operator. Where an invoice falls due on a nonbusiness day, we will expect payment to be received by close of business on the first Business Day preceding the due date.
